



FEES

Fees for the provision of Investment Services ;

Investment management fees are based on a % of the portfolio value and are charged quarterly.

Heritage Funds - Holdings in any of the **Heritage Funds** are subject to a charge of 0.0625% per quarter (**0.25% pa**) (including the SVS Heritage Balanced Portfolio Fund)

All other investments - The fees for investments in listed equities, investment funds, bonds and any other holdings within the Heritage investment account are dependent on the basis of management ;

Discretionary portfolio management	0.25% per quarter (1.0% pa)
Non-discretionary	0.125% per quarter (0.5% pa)

Notes ;

- The minimum portfolio size is £100,000
- The minimum quarterly charge is £50
- The minimum investment in the Heritage Funds is £20,000
(£10,000 minimum investment in the SVS Heritage Balanced Portfolio Fund)

Transaction fees on the sale and purchase of investments are based on the value of the transaction and where applicable are in addition to any stamp duty, exchange fees and brokers charges etc.

- There are **no transaction fees or initial charges** for investments in the **Heritage Funds** for Heritage clients.

Redemption of shares in the Heritage Funds

A bid-offer spread of 1.0% and 0.5% is applied to the Heritage Managed Portfolio Fund and the Heritage US Dollar Absolute Return Fund respectively to cover the costs duties and charges that would be incurred in realising the assets of the Funds, so as not to dilute the value of the holdings of the remaining investors.

Non-investment related administration

Any additional administrative work of a non-investment related nature that is required to be performed will be charged on a time basis.



COSTS AND CHARGES INFORMATION

This document provides with you with expected costs and charges information about the proposed mandate. It is not marketing material. This information is required by law and you are advised to read it so you can make an informed decision about whether to invest.

Heritage does not recommend a holding period for your portfolio, but for illustration purposes the below information relating to impacts that charges may have on your return is based on the first and subsequent years. THE CUMULATIVE EFFECT OF COSTS ON RETURN
