Investment Objective

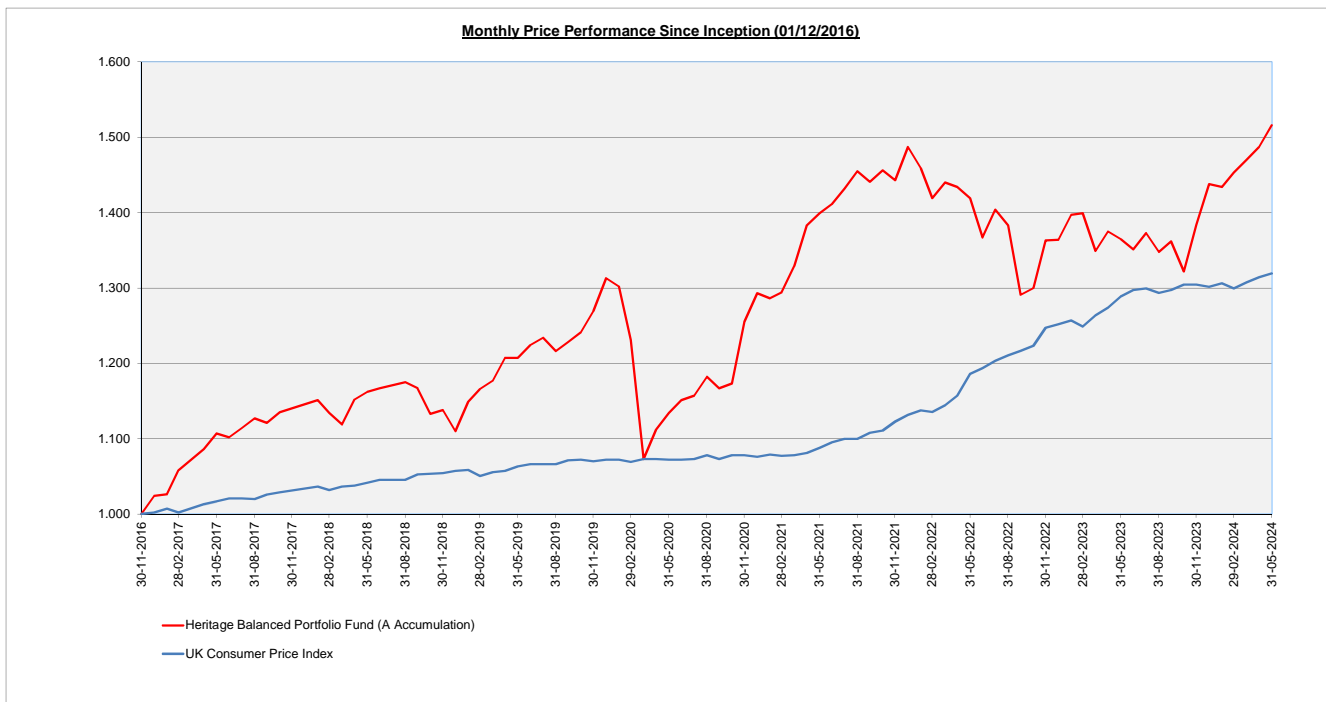
The Fund's investment objective is to achieve a total investment return (comprising of capital growth and income) over the long term (at least 5 years).

In the pursuit of the objective, the SVS Heritage Balanced Portfolio Fund will invest in a wide range of securities and asset classes including equities, preference shares, investment trusts and companies including Real Estate Investment Trusts, fixed interest securities including government, corporate and convertible bonds and cash or near cash instruments.

Commentary

The Balanced Portfolio Fund seeks to generate long-term capital growth at a lower risk than that associated with pure equity market investment through active management of a well diversified multi-asset portfolio. The Fund launched on 1st December 2016 and the portfolio structure and strategy is broadly in line with the existing larger offshore version of the fund (the Guernsey regulated Heritage Managed Portfolio Fund that has a successful track record of over 20 years).

The Fund had another positive month with a gain of 1.95% taking the year-to-date return to 5.42%.

The best performance from our share portfolio came from our holding in Bloomsbury Publishing which announced record results and other strong contributions were made by Standard Chartered, Schroders, Intermediate Capital, Computacenter, Greggs, Lloyds and System1. Our listed private equity fund holdings also had a good month with our largest holding, Oakley Capital, making the best contribution.

Following a difficult start to the year, with the expected reductions in interest rates have been pushed back until the second half, our property holdings and alternatives including infrastructure and renewables, had a better month in May.

Our various bond and other fixed income securities had a steady month and continues to generate an attractive income yield of 7%.

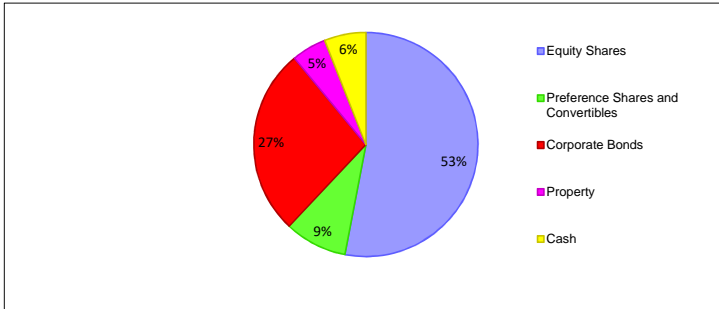
Although the near term outlook remains uncertain, we believe that our portfolio of well diversified investments is well positioned to generate attractive returns for long-term investors.

Asset Allocation



The equity content consists predominantly of profitable companies on attractive valuations as well as some international and specialist funds including private equity.

The preference shares and convertibles consist of zero dividend preference shares and bonds that have an option to convert into ordinary shares.

The property exposure is through funds and REITs that invest directly in commercial property as well as property company shares.

The corporate bond holdings consist of investment grade as well as some higher yield bonds and include both fixed and floating rate bonds.

Cash is held to manage risk and to provide liquidity.
